NOTICE OF CANDIDATE FILING DEADLINE

The general election will be Tuesday, November 2, 2021. The election will be held for the purpose of electing the following offices for the specified terms:

Mayor – 4 year term

City Council Seat (2) – 4 year term for each

Candidates for city elected office are required to file a Declaration of Candidacy specifying the office sought and confirming they meet the requirements:

- At least 18 years of age,
- A U.S. citizen,
- Candidate's primary residence must be within the city,
- Address of the candidate's voter registration must match the residence address provided on the candidate's declaration, and
- Candidate must have resided in the city for at least 30 days prior to submitting their declaration.

The Declaration of Candidacy must be accompanied by:

- A nonrefundable filing fee of \$40, or
- A Petition of Candidacy signed by at least five qualified electors with the signatures verified by the County Clerk's office.

Candidate Filing Period opens Monday, August 23rd.

FRIDAY, SEPTEMBER 3rd at 5:00 p.m.**

Salmon River Public Library

The Salmon River Public Library was awarded a grant of **\$10,300** in federal American Rescue Plan Act (ARPA) funding, which was granted through the Institute of Museum and Library Services and the ID Commission for Libraries.

Library Director Susan Hollenbeak said, "We are so grateful to receive this funding which will allow the library to provide new computers (and public printer) for our patrons use."

Throughout Idaho, 48 libraries of all types -- public, school, academic, and special, which includes tribal -- received this ARPA funding through a competitive grant process.

State Librarian Stephanie Bailey-White said, "The funds will be distributed to libraries around our state, which is another important factor in the tremendous impact this funding will make for Idahoans throughout the Gem State."



ADVANCED EMT COURSE

Cody Killmar, Elly Elder, Grace Killmar, and Fred Taylor have signed up for an intense Advanced EMT Course. After completion, the Riggins EMS will have more options for pain control and many other skills that would normally require a paramedic from McCall to come aid us. An Advanced EMT is one step below a Paramedic.

The class will take about 6 months to complete (the text book is 1,700 pages).

PUBLIC WORKS CORNER

The City is pumping an enormous amount of water through our City wells and water system. We ask that everyone be mindful about outside watering and comply with the Alternate Day Watering mandate.

Please don't waste this valuable resource!

ALTERNATE DAY SPRINKLING/WATERING IN EFFECT

Due to the high demand for water, in order to insure that all users have adequate water for irrigation, alternate day sprinkling and watering is in effect for both domestic well water and the Irrigation Ditch.

NORTH of the Elementary School = **EVEN** days

SOUTH of Elementary School (including the School) = **ODD** days

Hand Watering - allowed at all times.

All set sprinklers are subject to the Alternate Day Schedule.

The Riggins City Council asks for your cooperation to help make water available for the duration of the summer.

NORTH=EVEN

SOUTH=ODD
