PUBLIC HEARING – FY23-24 BUDGETS: Those present – Mayor McClure, Councilors Clay, Sampson and Wilson, and Jerry Wolcott.

Discussion centered around utility fees and the cost to operate water and sewer.

SPECIAL MEETING

September 6, 2023 – 10:15 a.m.

Mayor McClure called this special meeting to order. The purpose of the meeting is to review comments from the Public Hearing on the FY23-24 budget, and to approve budget documents.

Roll Call: Bill Sampson, Jonny Wilson, and Brady Clay. Akins was absent.

FISCAL YEAR 2023-2024 BUDGET

L2 Certification to Idaho County Commission: this is for the property tax levy of \$68,402. Motion was made by Wilson to approve the L2 Certification for the County; motion was seconded by Clay. Voting yea, Clay, Wilson and Sampson. No nays; motion carried.

Appropriation Ordinance #230 was presented:

AN ORDINANCE OF THE CITY OF RIGGINS, IDAHO, ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR FISCAL YEAR BEGINNING OCTOBER 1, 2023, AND ENDING SEPTEMBER 30, 2024, APPROPRIATING THE SUM OF \$5,947,521 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF RIGGINS FOR SAID FISCAL YEAR, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

A motion was made by Sampson to suspend further reading of the Annual Appropriation Ordinance #230; seconded by Wilson. Voting yea, Wilson, Clay and Sampson. No nays; motion carried.

At this time, a motion was made by Clay to accept Annual Appropriation Ordinance #230 for fiscal year beginning October 1, 2023 appropriation of \$5,947,521, and to publish the Ordinance in the Idaho County Free Press; seconded by Sampson. Mayor McClure conducted a roll call vote – yea, Sampson, Clay and Wilson. No nays; motion carried.

RESOLUTION #23-4 – Water, Sewer and Garbage Rate Increase: This resolution increases the monthly water, sewer and garbage rates effective October 1, 2023. Motion was made by Wilson to approve Resolution 23-4; motion was seconded by Sampson. Voting yea, Sampson, Clay and Wilson. No nays; motion carried.

RESOLUTION #23-5 – Ambulance Budget Amendment for FY23: This resolution amends the ambulance billing amounts effective July 1, 2023. Motion was made by Sampson to approve Resolution 23-5; motion was seconded by Clay. Voting yea, Clay, Wilson and Sampson. No nays; motion carried.

City Council meeting was adjourned at 10:35 a.m.

URBAN RENEWAL DISTRICT – BUDGET FY24: Public Hearing was held earlier with no comments received. Resolution #23-01 was presented to approve and adopt the budget of \$2,528,029. Motion was made by Clay to approve Resolution 23-01; motion was seconded by Wilson. Voting yea, Wilson, Sampson and Clay. No nays; motion carried.

There being no further business, the meeting was adjourned at 10:36 a.m.
